1. Apologies for absence were received by Councillor Mrs Ailia Lewis MBE and the Mayor, Councillor Keith Thomas

2. DECLARATION OF INTEREST BY ANY COUNCILLOR OR OFFICER:

4. PEIBIO PLAY PARK:

Mr Ian Pritchard stated that at the present time Orthios were in the process of obtaining Licenses and consents and were concentrating on the Polymer Production side of the proposed development and could not give a time-scale of when Orthios or Contractors would need access to any part of the tunnel which runs underneath the land at Peibio.

Councillors stated that the options they were keen on taking up would be 1) either adding small items of play equipment to be installed at the existing play – park or obtaining permission for the play park to be re-located on the same land with new equipment, then this Play park could be in situ for a long period of time.

Mr Ian Pritchard stated that he would take note of the Councillors' wishes and meet again in the future to discuss this further. He could not give a definite time of when the actual commencement of the Orthios works would commence until all the necessary documentation had been signed.

Mr Roberts (Anglesey County Council) stated that local businesses should be approached to see if they could provide some funding towards any new play equipment.

Mr Pritchard and Mr Roberts were thanked for attending the meeting and they left the Council Chamber at 1.25 p.m.

IN PRIVATE

To discuss the proposed new skatepark.

Mr Rob Henderson stated that he had been contacted by Mr Young the Contractor who had commenced the works on the new skate-park at the Town Park. Mr Young stated that there was a lot of rock in the land where the proposed skate-park was to be installed and located. He, therefore, suggested that a proposed amendment to the design had to be made but this would incur an additional cost of £6,000.00 but that the new design would provide more bike jumps and be a better design from the one originally proposed. Councillors were issued with a sketch of the new proposals.

*It was resolved,* proposed and seconded to approve the new design to the skate-park at a further cost of £6,000.00 and this fact would be made known to the members of the Finance/Property Meeting which would be meeting on 8<sup>th</sup> November 2018 at 10.30 a.m.
